## Terms of Agreement

1. The Mouse Detectives will donate \$25 for each Disney Destinations package vacation booked through The Mouse Detectives by friends and family of above mentioned organization. Disney Destinations included are the **Walt Disney World® Resort** in FL, the **Disneyland® Resort** in CA, **Disney Cruise Line**, and **Adventures by Disney®**.
2. Packages consist of any room, ticket, and dining plan combination at the **Walt Disney World® Resort** in FL, and the **Disneyland® Resort** in CA. If a dining plan is not included in a package, tickets must be 3 or more days at the **Walt Disney World® Resort** in FL. Tickets must be 2 or more days for any package booked at the **Disneyland® Resort** in CA. All **Disney Cruise Line** and **Adventures by Disney®** bookings are considered packages.
3. The Mouse Detectives will donate 5% of net commissions for any of the following bookings made by friends and family of above mentioned organization:
  - Disney Destinations room only reservations including the **Walt Disney World® Resort** in FL, the **Disneyland® Resort** in CA, and **Aulani, A Disney Resort in Ko Olino, Hawai'i**.
  - Ticket only purchases of 3 days or more at the **Walt Disney World® Resort** in FL, and 2 days or more at the **Disneyland® Resort** in CA.
  - Packages at the **Walt Disney World® Resort** in FL that do not include a dining plan, and include a ticket of 2 days or less.
  - Any non-Disney Destinations bookings including but not limited to other cruise lines, hotel chains, tour group packages, car rentals, stroller and wheel chair rentals, etc. (Unfortunately, airfare is not included in our fundraising efforts)
4. Donations are paid by check after the guest's travel on a quarterly basis. Quarterly payments are made on April 1, July 1, October 1, and December 31 of each calendar year.
5. A statement including travelers' names and amount of donation will be provided with each donation.
6. This fundraising opportunity is available year round. The Mouse Detectives reserves the right to reject any organization's application, and to terminate this agreement at any time. In the event that The Mouse Detectives decides to terminate this agreement, any

donations due to the above organization as a result of this agreement will be donated only after a thorough review of the cause of the break in the agreement.

7. Organization must provide a W-9 including their Federal Tax ID# to The Mouse Detectives before any donations can be made.
8. The organization recognizes that The Mouse Detectives, LLC is an independent travel agency and its members are not employees of The Walt Disney Company or any of its related, affiliated, or subsidiary companies.
